## SiLS moves to Bond University

As of January 2018, Swiss International Law School (SiLS) will be collaborating with the Faculty of Law at the renowned Bond University, Gold Coast, Australia to offer an online Master of Laws (LLM) International Commercial Law and Dispute Resolution.

This new LLM will continue to be offered entirely online, in an interactive manner, and using an intercultural and innovative teaching approach, while classes will remain small.

The new program features all four current SiLS online modules (Sales and Transport Law, Corporate Law, Dispute Resolution, Intellectual Property Law), each converted into a 20 cps Bond subject.

Feel free to study 4 x 20 cps subjects completely online, or combine online courses with on campus studies at Bond's Gold Coast campus in Australia. For example, you may complete 2x20 cps subjects online and 4x10 cps subjects on campus – or other individual combinations, depending on your personal needs and preferences. For maximal flexibility, it is also possible to study full time or part time, or even just take single subjects. Online and on campus courses start three times per year: in January, May or September.

Our curriculum is not linked to one specific jurisdiction, but strongly based on a genuine comparative approach. All scholars and experts teaching at SiLS have a strong background in the international academic world as well as in practice.

## Short Facts

**Study mode:** Either fully online, or a combination of online and on campus studies.

**Courses:** Four interactive online 20 cps subjects: Sales and Transport Law, Dispute Resolution, Corporate Law, and Intellectual Property Law. A variety of 10 cps subjects on campus, see the Bond website for more details.

**Duration:** Two semesters (full-time), three to four semesters (part-time), equivalent to a student effort of about 40 hours (full-time), or 20 hours (part-time) per week.

**Semester start:** January, May, and September. One semester at Bond university lasts 14 weeks. For exact dates in 2018, please consult the Bond academic calendar.

**Language:** English.

**Fees:** AUD 38,840 (whole program – 80 cps).
